

Because of the \$15,000 of advertising that has been sold by Illustrious Sir Bob Burr, we have enough money to pay for this year's start up and ten months of distribution. Al Kaly Shriners income comes mainly from the projects that we schedule each year. Dues are about one third of the budgeted income. Al Kaly Shriners are very active in managing the projects that contribute to the income side of the budget. Let me list the fundraising events: Circus, Golf Tournament, Raffle, Recycling, Gun Shows, Cruise, and Advertising. These events pay the salaries of our Office Secretary and Recorder, our office rent, the maintenance of our office equipment and support services, the Stated Meetings, Ceremonials, Parade Expenses, Insurance, Membership Programs, Family Night, Ladies Lunches, Picnic and Special Events, Imperial Training, Imperial Sessions, Shrine Club cups and napkins, and pins.

Because Al Kaly is very productive with the fundraising projects, we do NOT need to raise the dues or charge for the DUST. So remember, when asked to assist with a fundraiser, please say "YES."

THANK YOU, Al Kaly Shriners, for your continued support and hard work. I will never forget a talk that Dave Packard gave at a workshop dinner at Ignacio, Colorado some years ago. "Good work deserves more good work. Thank you!"



## Clayton L. "Ski" Novotney

When a fire broke out in the diesel room on his ammunition ship, he didn't think twice. Clayton L. Novotney rushed into the smoke-filled room, stumbling over what he thought were men who had already succumbed to

the fire and smoke, to assure himself that everyone was safely out. Barely able to see because of the thick smoke, he then risked his life to extinguish the flames before the explosives-laden ship could blow up. Fortunately, what he thought were bodies on the floor were really just life jackets that had been discarded by the men as they evacuated. His brave actions saved between 300 and 350 crewmembers that day.

Born January 1927, in Brainerd, Minn., Clayton Lowell Novotney, who regularly goes by the nickname "Ski," was raised on a 180-acre farm, where his family raised dairy cows. The youngest of four, he worked on the farm where it became his job, along with his brother, to milk the cows at dawn before going off to school. After school, it was more of the same milking cows, cleaning out stalls and other farm work.

In the heat, the rain, the snow and mud, he rode his horse to and from a one-room school, which housed first through eighth grades. "Sometimes the snow came up to the horse's belly," he recalled. After the eighth grade, "Ski" decided he had had enough of that life and decided to strike out on his own. Moving into a boarding house in town, he began working for the local railroad foundry.

Because World War II was in full swing, Novotney was itching to get into the thick of fighting, like most of the other men in his hometown. "I couldn't wait until my 17th birthday to join the Navy," he said....and 'not wait' is what he did, joining the Navy when he was 16 and a half. His decision was also made a little simpler by a visit from the Navy recruiter who made it clear to him




## SHRINE LADIES

Training Station he was assigned to an aircraft carrier, the USS Yorktown, thus beginning a 30-year Naval career, followed by 10 years with Naval related civil service.

During his career, he served in World War II, Korea, Vietnam and wherever he was needed, working his way up the ranks from seaman to lieutenant commander, which was quite a feat for a drop out, he agreed. Letting no unproductive time pass by, he had soon earned his GED high school equivalency certificate. "Ski' became an Entered Apprentice Mason in California when he was 24. As a sailor, he sometimes spent months at sea, which left him time to study Masonic ritual. When he turned 26, he was raised to the degree of a Master Mason, but he didn't stop there. He became a member of the Scottish Rite in 1956 and in 1957 he became a Shriner in Islam Temple in San Francisco. That same year, in Winterhaven, California, he was married to his wife Opal, whom he had met some four years before.

Novotney had previously purchased an apartment house in San Diego, and he lived there with Opal when he was in port, leasing the other nine apartments. His wife followed him to his

...Shore duty assignments in Cuba, Alaska and Guam. While stationed in San Diego, he served on the volunteer police force in San Diego and retired as a lieutenant. Along the way he



earned a merchant marine license. His last duty ship was the USS Mauna LOA AE-22. After he retired from the Navy as a licutenant commander, he worked for a year on the passenger liner "Mariposa."

At 47, Novotney decided he was too young to retire so he worked with the NASA space shuttle program for a year in Quality Assurance. From there, he built and maintained ships for the Department of Defense in San Diego. Later, he worked as a port engineer for a commercial shipping line for three years in London, England. Afterwards, Novotney returned to San Diego with the Department of Defense. Sandwiched in with all of his other activities, "Ski" received his Bachelor of Science degree in Law Enforcement from San Diego State in 1985. In 1992, he finally retired so he could fish and hunt.

After losing his wife, he met Rose Harris, who has been his companion for several years. They moved from San Diego to Durango, where they now live with two horses, two burros, three cats and a dog. "Winters can be harsh here," he said, "but compared to Minnesota, Colorado is like Florida."

Still feeling that he had things to do, he went to flight school and got his pilots license. Novotney continues to be involved with his friends, the local Veterans of Foreign Wars Post #4031, the Cattlemen's Association and Al Kaly Shrine, from which he was recently presented his 50-year pin by Ill. Potentate Bill Stoner. Although he continues to be an active supporter and participant in the San Juan Basin Shrine Club, Noble Novatney has never transferred his membership to Al Kaly and continues to be a member of his original Temple in California.

For his actions in saving his ship Novatney received a letter of gratitude from the Secretary of the Navy along with the Naval Commendation. Other citations and medals received during his career include the National Defense Service Medal, Vietnam Service Medal, four Bronze Stars and several other awards. Thanks, "Ski," for your courageous service to our country. We would love to have you as a member of Al Kaly!






#### "The F/Stops Here" By Bob Bills Al Kaly Photographer

The reports included such topics as CSSA financial status, CSSA and Shrine membership, DeMolay in Iowa, Scottish Rite in Iowa and the Grand Lodge in Iowa. The Hospital reports were also presented but I won't go into detail except to say the Cleft Lip and Palate program is approved and up and running at our burns center hospitals. That means the Galveston hospital is handling our patients for Cleft Lip and Palate. We also received reports (or pitches, some might say) on the upcoming CSSA Ceremonials in OK City 2008, Colorado Springs 2009 and again OK City in 2010. The corresponding winter business meetings for the same years were also covered. I am pleased to report that Tom, Rex and I all stayed in the room and awake during those reports!

We were very fortunate to have several Imperial officers there throughout the two days of meetings: Imperial Potentate Dr. Bernie Lemieux, Deputy Imperial Potentate Doug Maxwell, Imperial High Priest and Prophet Mike Severe, Imperial Outer Guard Chris Smith and Past Imperial Potentate Gary Dunwoody (and, yes, they were awake, too). One topic that all the Imperial officers were emphatic about was not combining the business session and the ceremonial (fun) session into one session because, in their experience with other

areas of the country, it ended in a watered down business session.

They all stressed that we, the voting representatives, must demand a business session that provides useful information that we can take back to our Temples to make them stronger. I think the CSSA board got the message and will honestly work on it.

The Deputy Imperial Potentate, Doug Maxwell, talked at great length about the future of our hospitals and some business improvements that will have to be made in the coming years. He stressed over and over again that we must look at them in a business fashion and base some tough decisions on business principles. He recognized that you cannot compare our hospitals to any others because we stand alone in the way we care for our children, but we are going to have to apply business principles when it comes to the numbers of our staff and the way our hospitals work. We should be looking at centers of excellence and maybe not all hospitals will provide the same type of care. He compared this year's budget of \$826 million to the \$3 million 30 years ago (1968) and said we can't keep this up. He assured us that our Imperial bospital board members are digging into this issue and understand how emotional budget cutting can be. He then really wowed us by telling us about the PGA Justin Timberlake/Shriners Hospitals for Children Open Golf Tournament in Las Vegas scheduled for 13-19 October. He ended his almost two hour talk by describing the 2008 Imperial Session in St. Louis that promises to be different and fun (especially if you like the Beach Boys in Concert). Stay tuned for more information on that topic.


We arrived home safely on Sunday after skirting some nasty snow and bad accidents between Burlington and Limon and, NO, not everyone stayed awake for the whole trip.

Joe'l a former Shriners Hospitals for Children Patient tells her story of coping with cerebral palsy.

My name is Joe'l. 1 am 21 years old and 1 am a former Shriners Hospitals patient. I have cerebral palsy that affects my right side

When I was a child, despite being told that I would struggle and not be able to walk, I began to walk on my own. As the years progressed and I grew from child to teen, I developed severe pain in my hip. Doctors told me there was nothing more that they could do for me that I would have to just live with it and I would struggle for the rest of my life. This would affect everything form walking long distances to taking care of a child.

When I was 17, I was introduced to Shriners Hospitals. They knew exactly what was wrong and how to fix it. I went through surgery and therapy and no I don't struggle like I did.

I am a college student studying graphic arts and design. In addition to being a student, I have also done some modeling work for different photographers across the U.S. and I have competed in beauty pageants.

I have written and recorded a tribute to the Shriners as my way of saying thank you for all you have done. The lyrics to the song were submitted to a poetry Web site where they were selected to be published in a book of poetry.

I married n 2006, and in 2007 I gave birth to our first son, Jacob. He is happy and healthy and I have no problems taking care of him.

My Life would have never been as successful if Shriners Hospitals had not been a part of it.

## HOSPITAL FACTS AND STATS By Bob Burr, PP

Illustrious Sir William Stoner asked that I prepare a brief for the Dust that gives you a recap of the activities at your Shrine Hospital in Salt Lake City and that is as follows:

Please take a special note: Intermountain Shriner's Hospital for Children is now Shriners Hospital for Children @ Salt Lake City (SLC).

This report covers the time period from January through December-2007.

- There were forty seven (47) patients admitted from the Al Kaly area
- The hospital admitted a total of 1,347 patients--up 7.8% from 2006
- There were 1580 applications for admittance--up 15.8% from 2006
- ▲ Our surgeons performed 1184 operations--up 7.9% from 2006
- Outreach Clinic visits totaled 1543--about the same as 2006

 Total Telemedicine patients seen at eleven of the fifteen clinic sites was 227

The Prosthetics and Orthotics Department at our Salt Lake City Hospital has proposed a Pilot Program to test the possible use of Micro Processor knees in children. This will be an on-going program at SLC and we are the first Shrine Hospital to do this.

SLC is ranked as one of the most efficient hospitals in the Shrine System. Staff satisfaction is rated in the top 10% of the Shrine Hospitals. Patient satisfaction is in the top 10% of the hospitals in the United States.

Building across the system: Construction projects are underway at Portland, St. Louis and Honolulu. Los Angeles will be rebuilding and has narrowed their new location down to two possible sites.

Members of Al Kaly Divan attended Divan Days at the Hospital in 2007 and now the Staff has scheduled Divan Days at the SLC Hospital for September 14-16, 2008. They are inviting the Divans, Public Relations Chairmen, Hospital Reps and any others that might like to take the trip.



#### SHRINE HOSPITALS 2008 BUDGET

Everything in our lives seems to increase in cost each year. Our Shrine Hospitals are no exception. Their 2008 budget is \$826 million dollars, an increase of \$105 million over last year. This is all due to escalating costs in health care, salaries, research, and daily maintenance.

For 85 years, all treatment and services have been provided at no cost to the family and still means that no child will be denied care for lack of funds.


We have, on many occasions during various lectures, quoted the 'cost per second' at \$20.00. In 2008 it is now \$26.19 every second of every minute of every hour of every day....365 days per year.

Of that \$826 million, \$678 million is designated for the hospitaloperating budget which includes patient care, teaching, and administrative expenses for all 22 Shriners Hospitals. \$44 million has been set aside for medical research.

Building and equipment expenditures have been increased to \$104 million, representing continued commitment to renovation, new construction, electronic medical records and other technological equipment.

Major construction projects included in this year's budget are: Chicago, Galveston, Honolulu, Los Angeles, Philadelphia, Portland, St. Louis, Shreveport and the Twin Cities. Visit www.shrinershospitals.org for more information.



Continue to support the Corps by attending all meetings and other get-togethers. A good show of solidarity may eventually pay off,



#### AN EXCERPT FROM GENERAL ORDER NO. 1: FUNDRAISING ACTIVITIES

It is natural to associate the fez with Shriners Hospitals for Children. Because of this, meticulous attention must be given to all fundraising activities, including circuses, to make certain that such activities comply with the law of the land and that a contributor is not led to believe that his money will be used for the Hospitals when all or a portion thereof will be used otherwise. The integrity of our charity and of our fraternity must remain above reproach.

Your specific attention is called to the following fraternal and charitable bylaws:

§335.3 USE OF NAME "SHRINERS HOSPITALS FOR CHILDREN." The use of the name "Shriners Hospitals for Children" or reference to the Hospitals in connection with any fundraising activity by a temple or Noble without the written consent of the Imperial Potentate and the Chairman of the Board of Trustees of the Hospitals is prohibited.

§503.10 The use of the name "Shriners Hospitals for Children" or reference to the Hospitals in connection with any commercial product or business enterprise is prohibited unless the written consent of the Board of Directors and Trustees has been first obtained.

Now, therefore, IT IS HEREBY ORDERED:

- 1. Fundraising for Fraternal Purposes:
  - (a) No Noble (in his capacity as a Shriner), club, unit, organization of Nobles or affiliated or appendant corporations shall engage in any fundraising activity without the express written consent of the potentate of the temple having jurisdiction thereof.
  - (b) There can be no representation, express or implied, that the proceeds will be for the benefit of Shriners Hospitals for Children.
  - (c) The temple potentate shall carefully examine all phases of the advertising, promotion and solicitation to determine that it complies with §335.3 and §503.10 of the fraternal and charitable bylaws.
  - (d) The temple potentate must approve the terms and provisions of any contract for a fundraising activity after receiving the advice of the temple attorney, and additionally, as may be required by the temple bylaws.
  - (e) A copy of the temple potentate's written consent shall be mailed to the Executive Vice President, Imperial Council. Further, such written material pertaining to the fundraising activity, as requested by the Executive Vice President, Imperial Council shall be promptly mailed to him.
- 2. Fundraising for Charitable Purposes:
  - (a) No Noble (in his capacity as a Shriner), club, unit, organization of Nobles or affiliated or appendant corporations shall engage in any charitable fundraising activity other than for Shriners Hospitals for Children, and said activity shall not be in the jurisdiction of any other temple. Permission therefore must be first obtained in writing from the temple potentate. The temple potentate must then obtain written permission from the Chairmen of the Boards of Directors and Trustees. This request for written permission shall be sent to the Executive Vice President, Imperial Council, P.O. Box 31356, Tampa, FL 33631-3356.

However, a joint charitable fundraising activity with another §501(c)(3) charity may be authorized provided that a minimum of 50% of the net proceeds are for the benefit of Shriners Hospitals for Children, and the Chairmen of the Boards of Directors and Trustees determine, on a case by case basis, that it is in the best interest of Shriners Hospitals for Children and they grant their written permission for the activity.

(b) 100% of net proceeds (as defined in the Charitable Fund Raising-Approval And Reporting provisions of any existing General Order) from charitable fundraising must be given to Shriners Hospitals for Children except for such portion thereof as may be permitted to be retained for the temple Shrine Hospital Patien

Transportation Fund, pursuant to the Special Purpose Funds provisions of any existing General Order. Provided, however, if the Chairmen of the Boards of Directors and Trustees determine for good cause shown, that the law of the land requires that a portion of the net proceeds must be distributed locally, then they may, if they determine it to be in the best interest of Shriners Hospitals for Children, grant their written permission for such distribution.

- (c) The temple shall report the result of each charitable fundraising activity within sixty days of the activity, pursuant to the Charitable Fund Raising-Approval and Reporting provision of any existing General Order.
- (d) This section shall not apply to activities exempt under §335.4(b) of the bylaws of The Imperial Council.
- (e) Each independent corporation or entity that receives the permission of the Chairmen of the Boards of Directors and Trustees to raise money for Shriners Hospitals for Children, and which does not have its financial statements audited pursuant to §334.5 & §337.8 of the bylaws of The Imperial Council, shall have its financial statements audited by a certified, chartered or licensed public accountant and shall submit such audit report to The Imperial Council within 120 days of the activity.
- 3. Statement of Purpose and Disclosure:
  - (a) Every fundraising activity must contain factual information on its solicitation material, tickets, programs and documents, including all electronically transmitted materials, regarding the use of the proceeds.

- (b) Every fundraising activity which is not entirely for the benefit of Shriners Hospitals for Children shall prominently state on the solicitation material, tickets and documents that "payments are not deductible as charitable contributions."
- (c) There must be compliance with the Revenue Act of 1987 provision of any existing general order by U.S. temples.
- 4. Compliance with Applicable Laws:

It is the responsibility of the temple potentate, after receiving the advice of the temple attorney, to determine that there is compliance with all applicable laws in its jurisdiction for the temple's fundraising activities.

- 5. Financial Records:
  - (a) The temple shall maintain detailed financial records pertaining to all fundraising activities involving Nobles, clubs, units, organizations of Nobles or affiliated or appendant corporations. Details of all revenues and expenditures shall be maintained in such financial records.
  - (b) The temple must retain such detailed financial records for a period of seven (7) years.
  - (c) There must be compliance with Financial Reporting on Charitable Funds and Activities provision of any existing general order.
- 6. Notification to Nobility:

A copy of the Fundraising Activities provisions of this General Order shall be printed in the temple publication at least once every calendar year. If there is no temple publication, then a copy shall be mailed to each Noble in the temple not later than the last day in March of each calendar year.

7. Discipline:

Any officer, Noble or temple which violates a provision of Fundraising Activities is subject to discipline pursuant to the bylaws of The Imperial Council.
