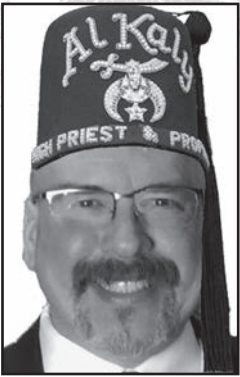

NEW MEMBER FOLLOW-THROUGH

I'm writing today about membership – and yes, I can already see you cringing at yet another anticipated scolding. But this isn't that. Each of us either knows a good candidate (Mason or Shriner) where we're just waiting for the right moment to prompt them; or we don't have any good notional candidates ... yet.

However, this missive is not about finding candidates, nor acting on them. This is about what happens AFTER you get them in, whether through their EA to MM degrees; or into Shrine with their first Fez. We all can probably think of a half-dozen who joined, and seemed really promising, but then trailed off and vanished. It's far too easy to view bringing in candidates as a recruitment/delivery exercise, when in fact, it's just the first step of a hundred. When you mentor someone into Masonry or the Shrine, you are assuming an obligation not just to deliver them; but to raise them in ways metaphorical, ritualistic, and psychological.

Now I could write about how to make them feel engagement or obligation, put them on Committees or giving them chairs, etc. But for Shrine, there's a better option – something Shriners have that Blue Lodges and many other bodies don't! No... not alcohol at the Shrine Club ... I mean UNITS.

Presumably when you pitch Shrine to a fellow Master Mason, you do so through a "Unit" event or activity – and best if it's an interest you share. Maybe multiple events. But ensuring they stay active really takes a mentoring effort; whether offering to drive them to the meeting, or teaching them the finer points of your unit, or trusting them with real duties. Think of it as an Apprenticeship in your Unit, not even Shrine per se. And you, as Mentor, should not take on too many Apprentices, just enough you won't neglect their education and integration -even if that means one at a time.

When I was first really recruited for Shrine, the hook was the Mule Train. I was invited in an introduced through the late and dearly missed, Noble Bo Cruz. And for a while, that looked likely to be my path in. But I'll be bluntly honest - it was a very tenuous thing that I kept on in Shrine. A combination of ongoing COVID back then, job changes, and the arrival of a new Colt in our own barn made it a very distant possibility to worry about the Mule Barn (much of that still applies years later, still training the colt for the saddle). And Noble Bo's passing left me without a mentor and an active "way in".

Fortunately, I'm a Brother at Ramah Lodge, which has a strong Shrine presence – and between Illustrious Sir Larry Weed, Noble Sir Cliff Wieger, and Noble Sir Randy Sanger; they pulled me back in. I didn't get into the Band, like IS Larry wanted – my drumming days are way behind and I can't keep up with the band's schedule. But I made a worse mistake – agreeing to join the appointed Divan!

Point of all that being, keep in touch regularly...every week even... with those you bring into Shrine. Try to keep them active in the units, club and activities that first interested them, or find a new direction to get their engagement anew.

And keep other Nobles in the loop, so if you get busy, someone else can pick up the slack. That is how we will not just attract new Shriners, but keep them, and grow.

FUNDRAISING ACTIVITIES

It is natural to associate the Fez with Shriners Hospitals for Children. Because of this, meticulous attention must be given to all fundraising activities, including circuses, to make certain that such activities comply with the law of the land and that a contributor is not led to believe that his money will be used for the Hospitals when all or a portion thereof will be used otherwise. The integrity of our charity and of our fraternity must remain above reproach.

Your specific attention is called to the following fraternal and charitable bylaws:

335.3 USE OF NAME “SHRINERS HOSPITALS FOR CHILDREN.” The use of the name “Shriners Hospitals for Children” or reference to the Hospitals in connection with any fundraising activity by a temple or Noble without the written consent of the Imperial Potentate and the Chairman of the board of Trustees of the Hospitals is prohibited.

503.11 The use of the name “Shriners Hospitals for Children” or reference to the hospitals in connection with any commercial product or business enterprise is prohibited unless the written consent of the Board of Directors and Trustees has been first obtained.

Now, therefore, IT IS HEREBY ORDERED:

1. Fundraising for Fraternal Purposes:

No Noble (in his capacity as a Shriner), club, unit, organization of Nobles or affiliated of

a. An appendant corporation shall engage in any fundraising activity without the express written consent of the temple having jurisdiction thereof.

b. There can be no representation, express or implied, that the proceeds will be for the benefit of Shriners Hospitals for Children.

c. The temple potentate shall carefully examine all phases of the advertising, promotion and solicitation to determine that it complies with 335.3 and 503.11 of the fraternal and charitable bylaws.

d. The temple potentate must approve the terms and provisions of any contract for a fundraising activity after receiving the advice of the temple attorney, and additionally, as may be required the temple bylaws.

e. A copy of the temple potentate’s written consent shall be mailed to the Executive Vice President – Shriners International. Further, such written material pertaining to the fundraising activity, as requested by the Executive Vice President – Shriners International, shall be promptly mailed to him.

2. Fundraising for Charitable Purposes:

a. No Noble (in his capacity as a Shriner), club, unit, organization of Nobles or affiliated or appendant corporations shall engage in any charitable fundraising activity other than for Shriners Hospitals for Children. Permission therefore must be first obtained in writing from the temple potentate. The temple potentate must then obtain written permission from the Chairman of the Boards of Directors and Trustees. This request for written permission shall be sent to the Executive Vice President, Shriners International, P.O. Box 31356, Tampa, FL 33631-3356.

may be authorized provided that a minimum of 50 percent of the net proceeds are for the benefit of Shriners Hospitals for Children, and the chairman of the boards of directors and trustees determine, on a case-by-case basis, that it is in the best interest of Shriners Hospitals for Children and they grant their written permission for the activity.

b. 100 percent of net proceeds (as defined in the Charitable Fundraising – Approval and Reporting provisions of this General Order) from charitable fundraising must be given to Shriners Hospitals for Children except for such portion thereof as may be permitted to be retained for the temple Shrine Hospital Patient Transportation Fund, pursuant to the Special Purpose Funds provisions of this General Order. Provided, however, if the Chairmen of the Boards of Directors and Trustees determine for good cause shown, that the law of the land requires that a portion of the net proceeds must be distributed locally, then they may, if they determine it to be in the best interest of Shriners Hospitals for Children, grant their written permission for such distribution.

c. The temple shall report the results of each charitable fundraising activity within sixty days of the activity, pursuant to the Charitable Fundraising – Approval and Reporting provision of this General Order.

d. This section shall not apply to activities exempt under 335.4b of the bylaws of Shriners International.

e. Each independent corporation or entity that receives the permission of the Chairmen of the Boards of Directors and Trustees to raise money for Shriners Hospitals for Children, and which does not have its financial statements audited pursuant to 334.5 and 337.8 of the bylaws of Shriners International, shall have its financial statements audited by a certified, chartered or licensed public accountant shall submit such audit report to Shriners International within 120 days of the activity.

3. Statement of Purpose and Disclosure:

a. Every fundraising activity must contain factual information on its solicitation material, tickets, programs and documents, including electronically transmitted material, regarding the use of the proceeds.

Examples: “Proceeds are for the benefit of (____ Shriners) (____ shrine club) Activities.”

“Proceeds are for the benefit of Shriners Hospitals for Children.”

b. Every fundraising activity which is not entirely for the benefit of Shriners Hospitals for Children shall prominently state on the solicitation material, tickets and documents that “payments are not deductible as a charitable contribution.”

c. There must be compliance with the Revenue Act of 1987 provision of any existing general order by U.S. temples.

4. Compliance with Applicable Laws:

It is the responsibility of the temple potentate, after receiving the advice of the temple attorney, to determine that there is compliance with all applicable laws in its jurisdiction for the temple’s fundraising activities.

5. Financial Records:

a. The temple shall maintain detailed financial records pertaining to all fundraising activities involving nobles, clubs, units, organizations of nobles or affiliated or appendant corporations. Details of all revenues and expenditures shall be maintained in such financial records.

b. The temple must retain such detailed financial records for a period of

seven years.

c. There must be compliance with Financial Reporting on Charitable Funds and Activities provision of any existing general order.

6. Notification of Nobility:

A copy of the Fundraising Activities provision of this General Order shall be printed in the temple publication at least once every calendar year. If there is no temple publication, then a copy shall be mailed to each Noble in the temple not later than the last day in March of each calendar year.

7. Discipline:

Any officer, Noble or temple which violates a provision of Fundraising Activities is subject to discipline pursuant to the bylaws of Shriners International.

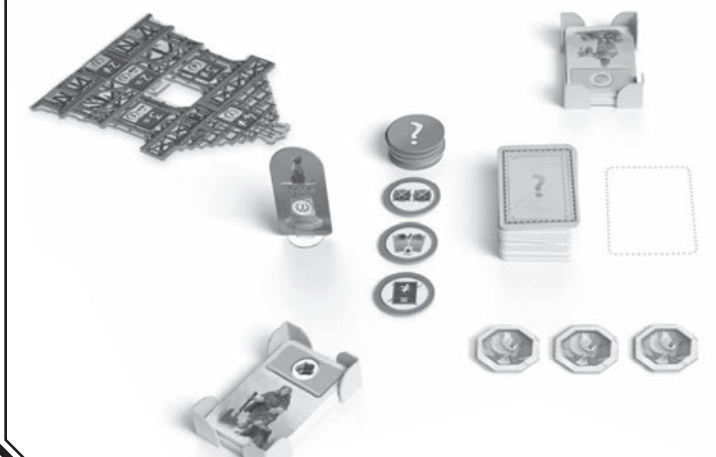
8PM ish to 11PM ish, following the COS Shrine Club Dinner on Wednesday, May 17th

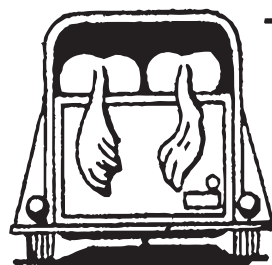
