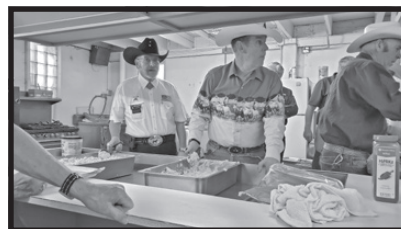
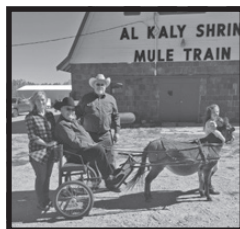
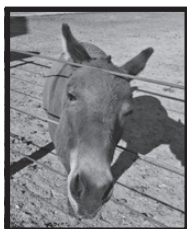

- 4) Restoration - Priorities include contacting the current delinquent members to inform them of their status, continue to work on previous years suspensions, assist with working current year Non Paid Dues, convene a monthly meeting to discuss progress and/or concerns

The Chairman has his own list of duties as well however, it becomes difficult to accomplish them without the assistance of a team. Far too many times we put membership on one person, and it is actually a team effort. As of now, we have two Nobles that have already stepped up to help, but we need more.

At the heart of being a Shriner is helping the children and supporting the mission of the Shriners Hospitals for Children. While it would be easy to depend on others to do the heavy lifting, being a Mason and a Shriner is about a greater picture; one that espouses Service Before Self, it's not an organization that can survive on individualism. So in order to keep the fraternity alive and active, here is your chance to be to make a difference in the continued success of Al Kaly Shrine. # TIDBITS FOR MEMBERSHIP GROWTH

I researched Webster, Oxford, Freedom Dictionary, Wikipedia, et al., with the intent of finding an appropriate definition for the word "membership". All either used the words "member", "group", or "society" in a futile attempt to accurately define the word, to my disappointment.

For a moment there, I experienced a conundrum that these well-known academic references were negligent by not providing me something that I could dig my teeth into until I realized that "Shriner membership" has meat, substance, and a clearly defined purpose. So I re-engaged my thought process and fine-tuned my research by searching for the term "Freemasonry" and found a more in-depth and well-defined, thought provoking definition: "Freemasonry: an instinctive sympathy or fellow-feeling between people with something in common [e.g. children]." I could have spent hours looking for a more eloquent definition for "Shriner membership" but given the audience of this article, further research was unnecessary.

So, why do I write this article? We, as Nobles (and to a huge benefit, the Ladies) are connected by a common bond and purpose—whether it be fellowship, a desire for philanthropic engagement, or improving the lives of our Shriners' children. Hence, as Shriners, we can display that vibrant calling to promote our philanthropic mission, recruit new members, and increase its rolls by confidently relying on the long-termed phrase, "Make a Good Man Better!" which, since time immemorial, has served as the Masonic objective.

Perhaps we can look at ourselves introspectively as being true pillars of our society and reflect on the old adage of "Ask One to Be One". For many years, I asked myself "why should I wait for a friend to ask me if they could become a Mason (Shriner, et al.)? Why couldn't I be pro-active and do the asking...of my next door neighbor, a co-worker, family member, or fishing buddy...all of whom I have known since forever?"

If we are genuinely concerned about attracting and retaining Al Kaly members, couldn't we make a conscious effort of spreading Shriners International's mission statement: "...providing the highest quality care to children with neuromusculoskeletal conditions, burn injuries and other special healthcare needs within a compassionate, family-centered and collaborative care environment"?

Granted, not every personality we come across has the desire to become Shriner but by the same token, why should we be reluctant or feel burdened by promoting the organization and its mission; or, have we reached a state of complacency where we are no longer proud of being a Shriner?

On a more uplifting note, I have noticed a tremendous growth in certain Blue Lodge membership over the past year. From my perspective, the reason for their growth can be attributed to the degree of "prioritization" given to recruitment and philanthropic activities—education notwithstanding—all of which creates positive impressions of these organizations in their communities and societies, which has eventually led to growth and long term retention.

We do not need a facelift. What we offer is not only special but a blessing to society. Perhaps we can start by spreading this blessing in our Appendant houses and not only recruit for prospective members from the craft but also encourage the Leadership to pursue a Shriner membership.

As a final thought provoking note: if we fail to confront complacency and disregard the pursuit of promoting the Shriner mission we may very quickly realize this "no-action" syndrome to be a nonnegotiable obstruction to our organization; but, worse yet, a devastating demise to Al Kaly, sooner rather than later.

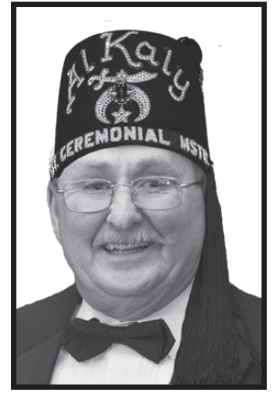

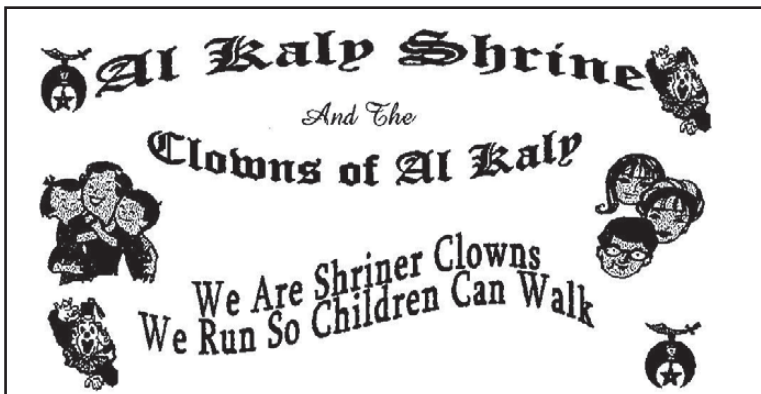

# FUNDRAISING ACTIVITIES

It is natural to associate the fez with Shriners Hospitals for Children. Because of this, meticulous attention must be given to all fundraising activities, including circuses, to make certain that such activities comply with the law of the land and that a contributor is not led to believe that his money will be used for the Hospitals when all or a portion thereof will be used otherwise. The integrity of our charity and of our fraternity must remain above reproach.

Your specific attention is called to the following fraternal and charitable bylaws:

**335.3 USE OF NAME "SHRINERS HOSPITALS FOR CHILDREN."**  
The use of the name "Shriners Hospitals for Children" or reference to the Hospitals in connection with any fundraising activity by a temple or Noble without the written consent of the Imperial Potentate and the Chairman of the board of Trustees of the Hospitals is prohibited.

**503.11** The use of the name "Shriners Hospitals for Children" or reference to the hospitals in connection with any commercial product or business enterprise is prohibited unless the written consent of the Board of Directors and Trustees has been first obtained.

Now, therefore, IT IS HEREBY ORDERED:

## 1. Fundraising for Fraternal Purposes:

No Noble (in his capacity as a Shriner), club, unit, organization of Nobles or affiliated of

a. An appendant corporation shall engage in any fundraising activity without the express written consent of the temple having jurisdiction thereof.

b. There can be no representation, express or implied, that the proceeds will be for the benefit of Shriners Hospitals for Children.

c. The temple potentate shall carefully examine all phases of the advertising, promotion and solicitation to determine that it complies with 335.3 and 503.11 of the fraternal and charitable bylaws.

d. The temple potentate must approve the terms and provisions of any contract for a fundraising activity after receiving the advice of the temple attorney, and additionally, as may be required the temple bylaws.

e. A copy of the temple potentate's written consent shall be mailed to the Executive Vice President – Shriners International. Further, such written material pertaining to the fundraising activity, as requested by the Executive Vice President – Shriners International, shall be promptly mailed to him.

## 2. Fundraising for Charitable Purposes:

a. No Noble (in his capacity as a Shriner), club, unit, organization of Nobles or affiliated or appendant corporations shall engage in any charitable fundraising activity other than for Shriners Hospitals for Children. Permission therefore must be first obtained in writing from the temple potentate. The temple potentate must then obtain written permission from the Chairman of the Boards of Directors and Trustees. This request for written permission shall be sent to the Executive Vice President, Shriners International, P.O. Box 31356, Tampa, FL 33631-3356.

However, a joint charitable fundraising activity with another 501c3 charity may be authorized provided that a minimum of 50 percent of the net proceeds are for the benefit of Shriners Hospitals for Children, and the chairman of the boards of directors and trustees determine, on a case by case basis, that it is in the best interest of Shriners Hospitals for Children and they grant their written permission for the activity.

b. 100 percent of net proceeds (as defined in the Charitable Fundraising – Approval and Reporting provisions of this General Order) from charitable fundraising must be given to Shriners Hospitals for Children except for such portion thereof as may be permitted to be retained for

the temple Shrine Hospital Patient Transportation Fund, pursuant to the Special Purpose Funds provisions of this General Order. Provided, however, if the Chairmen of the Boards of Directors and Trustees determine for good cause shown, that the law of the land requires that a portion of the net proceeds must be distributed locally, then they may, if they determine it to be in the best interest of Shriners Hospitals for Children, grant their written permission for such distribution.

c. The temple shall report the results of each charitable fundraising activity within sixty days of the activity, pursuant to the Charitable Fundraising – Approval and Reporting provision of this General Order.

d. This section shall not apply to activities exempt under 335.4b of the bylaws of Shriners International.

e. Each independent corporation or entity that receives the permission of the Chairmen of the Boards of Directors and Trustees to raise money for Shriners Hospitals for Children, and which does not have its financial statements audited pursuant to 334.5 and 337.8 of the bylaws of Shriners International, shall have its financial statements audited by a certified, chartered or licensed public accountant shall submit such audit report to Shriners International within 120 days of the activity.

## 3. Statement of Purpose and Disclosure:

a. Every fundraising activity must contain factual information on its solicitation material, tickets, programs and documents, including electronically transmitted material, regarding the use of the proceeds.

Examples: "Proceeds are for the benefit of (\_\_\_ Shriners) (\_\_\_ shrine club)

Activities."

"Proceeds are for the benefit of Shriners Hospitals for Children."

b. Every fundraising activity which is not entirely for the benefit of Shriners Hospitals for Children shall prominently state on the solicitation material, tickets and documents that "payments are not deductible as a charitable contribution."

c. There must be compliance with the Revenue Act of 1987 provision of any existing general order by U.S. temples.

## 4. Compliance with Applicable Laws:

It is the responsibility of the temple potentate, after receiving the advice of the temple attorney, to determine that there is compliance with all applicable laws in its jurisdiction for the temple's fundraising activities.

## 5. Financial Records:

a. The temple shall maintain detailed financial records pertaining to all fundraising activities involving nobles, clubs, units, organizations of nobles or affiliated or appendant corporations. Details of all revenues and expenditures shall be maintained in such financial records.

b. The temple must retain such detailed financial records for a period of seven years.

c. There must be compliance with Financial Reporting on Charitable Funds and Activities provision of any existing general order.

## 6. Notification of Nobility:

A copy of the Fundraising Activities provision of this General Order shall be printed in the temple publication at least once every calendar year. If there is no temple publication, then a copy shall be mailed to each Noble in the temple not later than the last day in March of each calendar year.

## 7. Discipline:

Any officer, Noble or temple which violates a provision of Fundraising Activities is subject to discipline pursuant to the bylaws of Shriners International.

# FEATURED SHRINER – TOM SANDERSON

Tom was born and raised in Colorado's San Luis Valley and attended school, K - 12, at Sargent High School located between Monte Vista and Center, Colorado. His dad supported his family as a farmer; he enjoyed raising sheep and tending to his potato and grain crops.

Tom attended Mesa College in Grand Junction where he earned an Associate's Degree in Computer Programming. After two more years at Adams State, he earned a Bachelor's Degree in Business Education. He interned for his student teaching certification in Colorado Springs at Widefield High School. During this time, he taught business law and keyboarding. He reminisced about a senior, a business law student. The student didn't believe Tom would flunk him if he didn't turn in his work; the student flunked and they all learned: "don't mess with Mr. Sanderson". Upon completing his student teaching, he received an offer for a teaching job that paid \$13,500. Back then, that was a lofty salary! Around the same time Tom's dad wanted to retire; so Tom decided to return home and take over the farm.



Tom met Margaret in 1962. He shared a funny story from when they were dating. They went on a double date to a drive-in movie with friends; Tom and Margaret were in the back seat. Margaret was wearing shorts and Tom had pulled his pant leg up to appear as if he was also wearing shorts to imitate her. She reached over to pull his pant leg down when he decided to flex his calf muscle. Tom was a football player so he had decent size calves. Margaret couldn't get his pant leg down over his calf. Without thinking she said, "Relax, Tom I can't get your pants down!" In that split second, the couple in the front seat immediately whipped around to investigate! Fast forward: they got married in 1972 and have two kids. Their son is in El Centro, CA, working in the agricultural industry. Their daughter is a dermatologist in Colorado Springs and she and her husband have three girls.

Tom is a passionate mule rider and he owns two mules. Since he was three years old, he can't think of anytime in his life when he has been without his four-legged animals. For a time, he had a job as a Wildlife Technician where he was able to ride his mule to locate moose, desert bighorn sheep and to perform checks on his assigned wildlife area. One job he really loved was raising crops for wildlife. Additionally, he spent time working at CO State University as a Research Farm Manager and for the Department of Transportation. Since 1994, Tom has been a substitute school bus driver; he finds enjoyment in interacting with the children.



It was in the late 80's when he decided to become a Mason at Monte Vista Lodge #73 and also joined the Fruita, CO lodge in the early 2000s. His granddad and uncle were masons so it was logical and natural for Tom to follow their

example. On Friday mornings, the Fruita lodge had breakfast at a local restaurant. Any time Tom wasn't there, he would receive calls checking to make sure nothing was wrong. Small towns can be wonderful places. He joined the Al Kaly Shriners in the mid-90's. While working in Fruita, he also joined El Jebel Temple Shriners. During his time with El Jebel, he became a clown and joined the Little T's. When he returned to his hometown, he resumed his participation in the Sand Dunes Shrine Club as a member of the three-wheelers and he transports "Smokin' Charley".

The care Shriners Hospitals for Children gives to the children is what drew Tom to become a Shriner. He loves representing the Shriners as a clown; the joy and smiles it brings to the faces of the children is priceless. Currently the Sand Dunes Shrine Club is working with two young girls who have orthopedic conditions. One of the girls is currently 15 years old and her condition is rather complex; it was determined the Philadelphia hospital would be best suited to treat her condition. For all her life prior to becoming a Shriners Child, she was unable to walk. With the hospital's treatment, she is now been able to stand on her own. Her progress has been nothing short of miraculous. The other girl who is much younger is being treated at the Shrine Hospital in Salt Lake City; she shows signs of improvement with each hospital visit.



Tom is honored to be serving as President of the Sand Dunes Shrine Club; he's currently on his third term. In addition to his presidency, he is also a hospital representative. He is concerned about the declining membership which affects their ability to accomplish their goals. The wives are a huge part of the club. Their support is invaluable and they help with the Shrine Circus. Most recently, they dedicated several hours in Alamosa during iHop's pancake breakfast where over \$1200 was raised.



Over 20 years ago, Monte Vista Lodge #73 built a beautiful lodge hall. While researching and working on ways to raise the capital necessary to construct the facility, they surprisingly received a check from a brother Mason. The check was for \$100,000 and all their worries were gone...the lodge was built with zero debt! While major work such as the cement floors, iron work, and heat in the floors was contracted out, the members rolled up their sleeves and labored away at most of the interior finish work. They are proud of their facility and while they do rent out the hall periodically, they are very selective about their clients. Annually they throw a venison banquet which is a popular local event.

Tom finds quiet and peace in the mountains where his cell phone is left behind! His philosophy is simple: Enjoy Life!

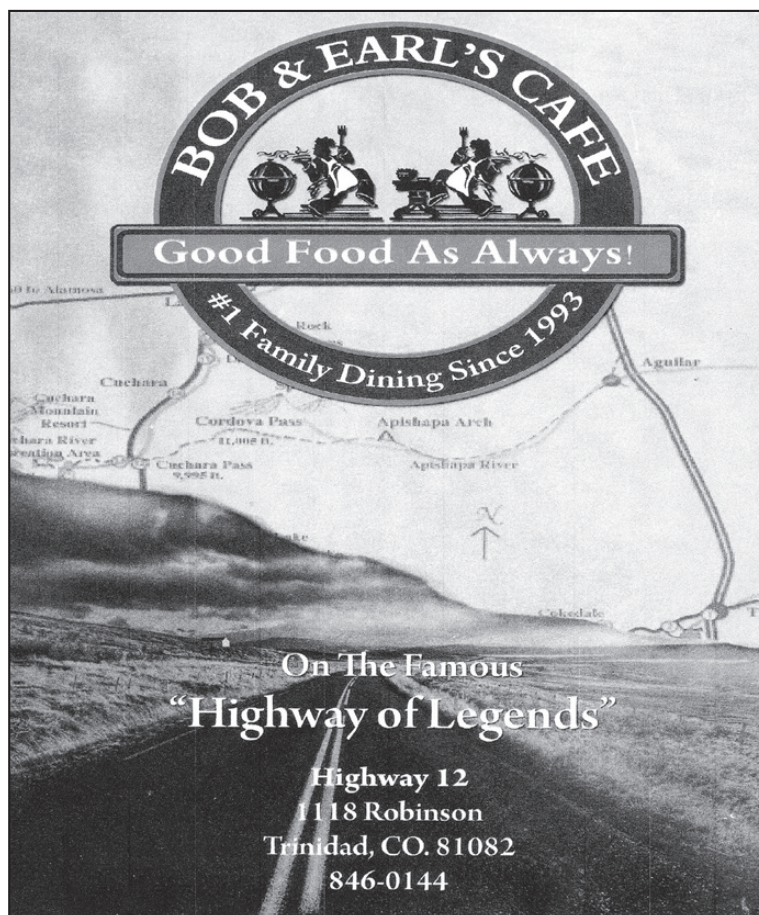

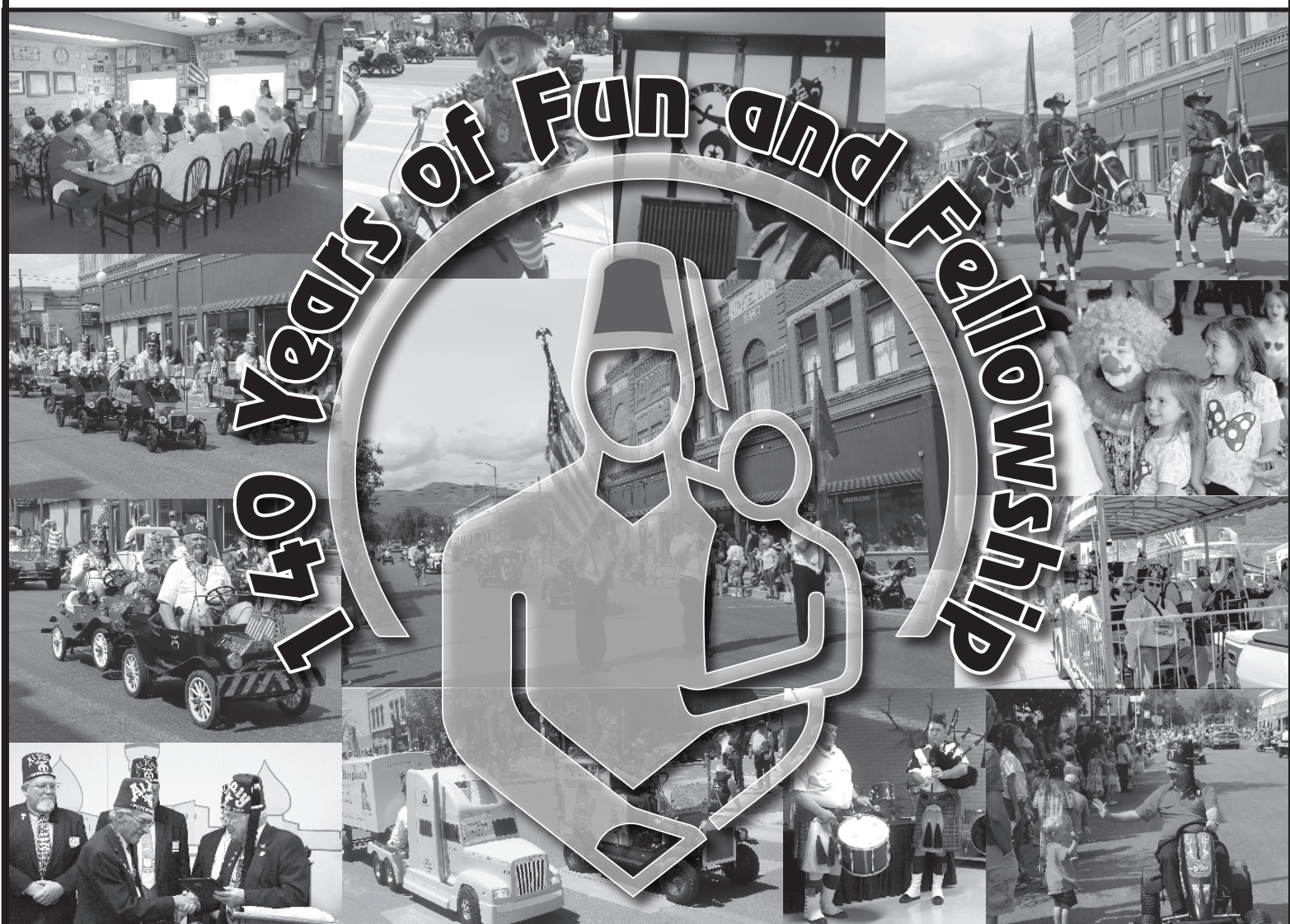
