# John Anderson

Clark Kent is alive!! I know this for a fact; I just met the quiet, mild mannered gentleman who, sometime during dinner, crept out of a phone booth and became Superman.

John Wesley Anderson was born in Wayne, Nebraska in January 1954 and moved to Colorado with his family two years later. Soon after, his parents divorced and mother found herself needing a job. In 1957 Colorado Springs Police Lt. Red Davis was looking to hire the first Meter Patrol Officers and John's mother found herself wearing Meter Patrol Badge Number One. Shortly after beginning work with Lt. Davis she was introduced to her lieutenant's brother Gary and in 1958 they married.

Now... with a single mother working in the police department, John had the "Fear of God" installed into his brain at a young age. He admits he was a "boy" and may not have been perfect, but did nothing that would ever have involved the police. Also, during this time he looked forward to Christmas and other "get-togethers" at Grandma's where he could listen to Uncles Red and his brother Les, also a Colorado Springs Officer, telling "war stories" of their arrests and cases at work. He had officially been bitten by the law enforcement bug.

By the time John graduated from Ellicott High School in 1972 he had been a Colorado Springs Cadet for a year and continued there until 1975. "Uncle Red" had become Assistant Chief Davis at this time and John was turning 21 years old. He tested for an officer position, was moved into dispatch where he worked for three months and was hired as a Colorado Springs Police Officer three days after his 21st birthday. Red later retired and became the 24th sheriff of El Paso County.

His career with the Colorado Springs Police Department took him to "the streets," the Training Academy, Detectives and saw him promoted to sergeant in 1986. As Sergeant he supervised in Patrol, the Academy and Traffic, Internal Affairs, and Community Relations. John also received a Bachelor of Business Administration in 1990 and an MBA in 1994, both from Regis College, before being elected the 26th Sheriff of El Paso County, also in 1994.

Nineteen ninety-four brought more good luck for John; during his campaign for sheriff he met with a supporter whose pro-tem receptionist, Brenda, caught his eye. They dated, were married March 7, 1997 and have a 12 year old daughter Laynie Reid Anderson. He is obviously proud in telling that Brenda is a direct descendent of Daniel Boone (a Mason) and her uncle Gordon Maze is a PM and a Shriner in Illinois.

During his stint in Detectives he met the nationally recognized Lou Smit and became life-long friends with him. Lou was hired in 1995 by Sheriff Anderson and assigned to solve the long "cold" Heather Dawn Church homicide, which he did. Lou and John were both present at the arrest of the killer who lived about ¾ of a mile from the Church family.

After two terms (term limits still exist in El Paso County) and 30 years in law enforcement John again retired. He then went to work at Lockheed-Martin for Ret. Lt. Col. Al Sarno (a Mason and Shriner) whom he met around 1996 through the Sheriff's Department.

Twenty-five years ago John joined the Masons in Colorado Springs. Although he has had "a life interwoven with cops and Masons" he specifically recalls Police/

Masonic encounters with Sgt. Mike Tooley, Chief John Taggart and Det. Capt. Vic Morris. Vic, who recently passed away, was Grand Sentinel and husband of Past Worthy Grand Matron Trude Morris.

He has seen many military Masons who display patriotic and personal values and follow ideals proffered by the Masonic organizations while in our country and others.

In Southern Colorado Consistory he was able to perform degree work with Illustrious Sir Jerry Sube.

As part of the Lockheed Martin team working with the Small UAV (Unmanned Aerial Vehicle) in Technology Transfer – where military technology is scouted for use in the civilian arena - John has been able to work with Homeland Security and Homeland Defense agencies.

(For those unfamiliar with Homeland Defense these are the protectors of our national soil and 500 nautical miles out to sea including all of Canada and Mexico. These boundaries give us the best possible protection of our daily comings and goings from attack.) In this position he has worked with Program Managers for the three Desert Hawk UAVs and assisted with the Advanced Technology

Demonstrations of these vehicles in many places. This is an awe inspiring “plane” or “glider”, electrically powered and therefore quiet, about 3-4 feet in length, remotely controlled from a fixed or mobile command center and able to be launched by hand. Imagine...

During the interview he periodically gave me that “I’d answer the question but I’d have to kill you” look...so please understand he couldn’t answer the fun questions so I can’t print them. Didn’t I tell you I had met Clark Kent?

While in Africa in March John again met Masons.



He was in Djibouti at the former French Foreign Legion Camp, La Lamonier when he saw a familiar lapel pin. After ascertaining the gentleman’s affiliation he found the man to be from the Philippines and had a nice conversation with him. Walking out the door and down a hallway he again met a man and found there were two in the building (and others in camp) from El Paso County.

Any of you who find interesting the discussion on the UAV and associated technology – including an exoskeleton fitted to a person and enabling them to “jump small buildings in a single bound” and lift unbelievable amounts of weight with its possibilities in the military, civilian law enforcement and other civilian applications – can go onto the Internet at [www.lockheedmartin.com/how](http://www.lockheedmartin.com/how) and explore this and other

fascinating technology with which John is involved.

A parting story John left me with. Pueblo County Sheriff’s Commander Chip DeLuca has a brother, Tim, who is with the El Paso County Sheriff’s Department. Brother Tim married Janet, John’s ex-assistant and a single mother with two boys, one of which has a birth defect, leaving him with only part of one arm. When she found John was a Mason and a Shriner she related to him

their experience with the Salt Lake Shriner’s Hospital and the semi-annual trips made for multiple years of the boy’s growth to replace, fit and refit the prosthesis which gave their son a chance for normal life.

As this Superman said, when you write a check to most of the assistance organizations you see only 12 – 20% of it actually getting to the people who need the help. When you write a check to the Shriners you can actually see 100% of that money arriving at a hospital and helping a child. There are no “administrative fees” or other hidden expenses taken out as everyone below the hospital is a volunteer and the money gets where you intended it to go.

Thank you for all you have done and continue to do for your community and your nation making the Masons and Shrine proud of you.

A closing personal remark...while in Africa last March, John’s mother passed away. His return trip brought him home just in time for her funeral. The Al Kaly Shriners would like to extend our deepest sympathies to the Anderson family at this time.


Shriners International is sponsoring two new internet sites for Shriners and potential new Shriners and Masons. Take a few minutes to check these sites, they are great!

The first site, [www.beashrinernow.com](http://www.beashrinernow.com), is designed for potential new Masons and Shriners: there are videos explaining the procedures to become a Mason and a Shriner, as well as hospital and patient videos. The site also explains how candidates can sign up to be connected with a virtual mentor, who can offer advice and answers to their questions. The site also offers detailed information on the Masonic Fraternity, Shriners, the Shriners Hospitals, how to become a Mason and a roadmap for their Masonic journey. The site is loaded with useful information such as four different membership videos, several public relations videos, and hospital videos. Again this can be a tool for your investigating committee to show to friends and potential candidates. There is also updated news about Shriners International and the Shriners Hospitals, a Shriner merchandise market to purchase Fraternity logo, Shrine protocol, Shrine directory, upcoming events, downloadable flyers, Temple list with contacts, and much more. # A "DON'T MISS" MASONIC TREASURE

The next time you have a chance to go to Washington D.C., don't miss your chance to visit one of our country's great memorials that contains some fantastic Masonic history. This "must see" tourist site is the George Washington Masonic Memorial, which sits on the top of a hill in Alexandria, VA.

When George Washington was inaugurated as the first President of the U.S., he also held the office of Master of the Alexandria Lodge. The Washington family and friends donated significant artifacts to the Lodge over the years, but in 1781 a fire destroyed much of the collection. In February of 1910, the Grand Master of Virginia held a meeting in Alexandria to build a befitting and fireproof memorial to George Washington, the Mason. He invited every Grand Master in the U.S., forming the George Washington Masonic National Memorial Assoc. It was ten years before the plan for a six story memorial "lighthouse" to Washington was approved by the Grand Lodges of the U.S.

In 1922, the groundbreaking ceremony took place on the hilltop site. Because of the great expense for the project, the association agreed that construction would go forth only as money was collected. The cornerstone was dedicated in November of 1923. President Calvin Coolidge and other dignitaries performed the ceremony before a crowd of thousands of Freemasons from around the nation.

For over ten years, Freemasons steadily worked on the construction of the memorial. Although the outside was finished and dedicated in 1932 by President Herbert Hoover, the interior proceeded slowly until after WWII. The memorial was not completed until 1970.

The memorial holds many artifacts and the history of American Freemasons, as well as being a lasting monument to Brother George Washington the man, the Mason, and the Father of our country. It is privately funded by contributions of Freemasons and others, making it free to the public seven days a week.

# PARADE TIME!



# FROM THE SHRINE TREASURER'S ASSOCIATION

I recently attended the Shrine Treasurer's Association conference in Tampa, FL. We had presentations by several members of the Imperial headquarters, and I think you would be interested in a couple of those. The Imperial Treasurer (Gene Bracewell) told us that:

- there will not be a proposal in Toronto to increase the per capita
- the Colorado Corp. investments are up about 19.66%
- the 1st group of five hospitals will start doing 3rd party billing in July
- based on information developed with the assistance of Price Waterhouse Coopers (PWC), it's forecasted that in about four years our hospitals should be receiving about \$180 Million/year from 3rd party payers.

Imperial Sir Doug Maxwell also spoke to us about the hospitals. He pointed out that in working with the consultants from PWC they found that the hospitals that stand to bring the most back in 3rd party billing are some of those that were on the list to become day clinics. He also said that day clinics only get paid about 25% of the amount that a regular hospital would receive for the same procedure. That's due to industry-related expenses of maintaining and running a hospital vs. a clinic. Much of the discussion in Toronto will be asking to give the board more time before they make recommendations as to changes to our hospital system.

# FUND RAISING ACTIVITIES

It is natural to associate the fez with Shriners Hospitals for Children. Because of this, meticulous attention must be given to all fund-raising activities, including circuses, to make certain that such activities comply with the law of the land and that a contributor is not led to believe that his money will be used for the Hospitals when all or a portion thereof will be used otherwise. The integrity of our charity and of our fraternity must remain above reproach.

Your specific attention is called to the following fraternal and charitable bylaws:

**335.3 USE OF NAME “SHRINERS HOSPITALS FOR CHILDREN.”** The use of the name “Shriners Hospitals for Children” or reference to the Hospitals in connection with any fund-raising activity by a temple or Noble without the written consent of the Imperial Potentate and the Chairman of the board of Trustees of the Hospitals is prohibited.

**503.10** The use of the name “Shriners Hospitals for Children” or reference to the hospitals in connection with any commercial product or business enterprise is prohibited unless the written consent of the Board of Directors and Trustees has been first obtained.

Now, therefore, IT IS HEREBY ORDERED:

## 1. Fund Raising for Fraternal Purposes:

No Noble (in his capacity as a Shriner), club, unit, organization of Nobles or affiliated or appendant corporations shall engage in any fund-raising activity without the express written consent of the temple having jurisdiction thereof.

- a. There can be no representation, express or implied, that the proceeds will be for the benefit of Shriners Hospitals for Children.
- b. The temple potentate shall carefully examine all phases of the advertising, promotion and solicitation to determine that it complies with 335.3 and 503.10 of the fraternal and charitable bylaws.
- c. The temple potentate must approve the terms and provisions of any contract for a fund-raising activity

after receiving the advice of the temple attorney, and additionally, as may be required the temple bylaws.

d. A copy of the temple potentate’s written consent shall be mailed to the Executive Vice President – Imperial Council. Further, such written material pertaining to the fund-raising activity, as requested by the Executive Vice President – Imperial Council, shall be promptly mailed to him.

## 2. Fund Raising for Charitable Purposes:

a. No Noble (in his capacity as a Shriner), club, unit, organization of Nobles or affiliated or appendant corporations shall engage in any charitable fund-raising activity other than for Shriners Hospitals for Children. Permission therefore must be first obtained in writing from the temple potentate. The temple potentate must then obtain written permission from the Chairman of the Boards of Directors and Trustees. This request for written permission shall be sent to the Executive Vice President, Imperial Council, P.O. Box 31356, Tampa, FL 33631-3356.

However, a joint charitable fundraising activity with another 501c3 charity may be authorized provided that a minimum of 50 percent of the net proceeds are for the benefit of Shriners Hospitals for Children, and the chairman of the boards of directors and trustees determine, on a case by case basis, that it is in the best interest of Shriners Hospitals for Children and they grant their written permission for the activity.

b. 100 percent of net proceeds (as defined in the Charitable Fund Raising – Approval and Reporting provisions of this General Order) from charitable fund raising must be given to Shriners Hospitals for Children except for such portion thereof as may be permitted to be retained for the temple Shrine Hospital Patient Transportation Fund, pursuant to the Special Purpose Funds provisions of this General Order. Provided, however, if the Chairmen of the Boards of Directors and Trustees determine for good cause shown, that the law of the land requires that a portion of the net proceeds must be distributed locally, then they may, if they determine it to be in the best interest of Shriners Hospitals for Children, grant their written permission for such distribution.

c. The temple shall report the results of each charitable fund raising activity within sixty days of the activity, pursuant to the Charitable Fund Raising – Approval and Reporting provision of this General Order.

d. This section shall not apply to activities exempt under 335.4b of the bylaws of The Imperial Council.

e. Each independent corporation or entity that receives the permission of the Chairmen of the Boards of Directors and

Trustees to raise money for Shriners Hospitals for Children, and which does not have its financial statements audited pursuant to 334.5 and 337.8 of the bylaws of The Imperial Council, shall have its financial statements audited by a certified, chartered or licensed public accountant shall submit such audit report to The Imperial Council within 120 days of the activity.

**3. Statement of Purpose and Disclosure:**

a. Every fund-raising activity must contain factual information on its solicitation material, tickets, programs and documents, including electronically transmitted material, regarding the use of the proceeds.

Examples:

*“Proceeds are for the benefit of (\_\_\_\_ Shriners) (\_\_\_\_ shrine club) Activities.”*

*“Proceeds are for the benefit of Shriners Hospitals for Children.”*

b. Every fund-raising activity which is not entirely for the benefit of Shrines Hospitals for Children shall prominently state on the solicitation material, tickets and documents that “payments are not deductible as a charitable contribution.”

c. There must be compliance with the Revenue Act of 1987 provision of any existing general order by U.S. temples.

**4. Compliance with Applicable Laws:**

It is the responsibility of the temple potentate, after receiving the advice of the temple attorney, to determine that there is compliance with all applicable laws in its jurisdiction for the temple’s fund-raising activities.

**5. Financial Records:**

a. The temple shall maintain detailed financial records pertaining to all fund-raising activities involving Nobles, clubs, units, organizations of Nobles or affiliated or appendant corporations. Details of all revenues and expenditures shall be maintained in such financial records.

b. The temple must retain such detailed financial records for a period of seven years.

c. There must be compliance with Financial Reporting on Charitable Funds and Activities provision of any existing general order.

**6. Notification of Nobility:**

A copy of the Fund-Raising Activities provision of this General Order shall be printed in the temple publication at least once every calendar year. If there is no temple publication, then a copy shall be mailed to each Noble in the temple not later than the last day in March of each calendar year.

**7. Discipline:**

Any officer, Noble or temple which violates a provision of Fund-Raising Activities is subject to discipline pursuant to the bylaws of The Imperial Council.



What happened to the new Nobles you sponsored, as a first line signer?



## *Spend the Income, Not the Principal*

I regularly speak with individuals who have portfolios largely made up of Stocks or Stock Mutual Funds. The practice is to use the principal from these accounts for income in retirement. That's ok in periods where the markets are predictably going up, but a disaster when the markets are falling.

Intuitively, we know that removing money from a portfolio that is falling will be compounding an already existing problem. So funds removed from an IRA are not able to be replaced. It sounds simple, but you would be surprised at how many portfolios I see that are largely built with stocks. Cashing in stocks kill the income stream and over time will deplete the account.

Income comes from investments that pay income. Stocks and stock Mutual Funds generally don't pay the kind of income required at income. Income investments are broadly Bonds, Preferred Stocks, and other Alternative income investments.
