

First Lady's Note

THE SHRINERS HOSPITAL FOR CHILDREN

The hospital opens its arms wide to embrace the Shriners who visit, but when you go as a group to have them show off the facility, you get the Royal Tour. We saw the gait lab that helps the doctors figure out possible surgeries, and it helps the physical therapists and occupational therapists to make a more efficient plan for

correcting or helping the child adapt to the condition. It is a real Star Wars sort of lab with 10 cameras for one procedure and 4 or 5 video cameras that film the process. They also have a floor sensor that can measure the foot pressure and how the foot actually lands and the way they actually put pressure on the mat. Next we saw the wheel chair lab. We learned the details that go into assuring that a child will be comfortable, be able to move with ease. and avoid the sores that come from the pressure of sitting without being able to adjust, or perhaps feel, pressure points. I never knew there were so many types and different functions for wheelchairs. Al Wetmore has gone through their training and is an expert on fitting wheelchairs (as well as repairing and reconditioning them) and crutches. The last lab we saw was the prosthetic lab. It is truly amazing to see the various stages and steps that are taken to assure that the prosthetic works correctly, is comfortable, and allows the child to function with his/her peers.

Most of the women's groups in Al Kaly send things to the hospital for the children. When we visited the women's sewing room, we saw what they do and what they need. They make bags, of all different sizes that allow them to give the children the toiletries that they need. They also

Featured Member Vic Sestokas by Charlotte Burrous

During the invasion of Italy, he was injured so badly that he was given last rites.

It happened when Vic Sestokas and the Allied Forces invaded Italy, where he and a crew were sent to pick up mines and booby traps. "We made a wrong turn on a road and saw a German tank," he said. "We tried to turn around and five days later, I woke up in the hospital."

In Italy, "they said I laid there for four days. My blood froze to my pants, (which) kept me from bleeding to death. They sent a team of officers to talk to my wife, Doris." In addition to numerous wounds, he suffered from pneumonia and pleurisy, losing 105 pounds.

Born Dec. 15, 1922, in Pittston, Pa., Sestokas left school to join the Army in April of 1940 when he was 17. Originally, he attempted to join the Marine Corp, the Navy and the Air Corp, but when he threatened to go to Canada to join its military, he was told there was an opening in the Army Corp of Engineers.

During the Invasion in Africa, he crossed the Atlantic Ocean where "there must have been a couple hundred ships," Sestokas said. "Every once in a while, one of them would blow up."

After the first group landed, it was still dark when the commanding officer told Sestokas to get his men ready to land. "I said, 'what do you mean, we're engineers," said 85-year-old Sestokas. "He said 'you capture a place, then you're engineers."

After making the North African invasion, the men threw away their blocked up rifles and picked up the Springfield action rifles.

One day, "one of my boys was sitting there cleaning his gun," Sestokas said. "Rummel had beaten us pretty bad. The Battleship Texas was out there throwing bombs over our heads," which caused the enemy to withdraw after they blew up the tanks. This was when Sestokas met Gen. George C. Patton for the first time, when Patton asked a man who was cleaning his gun where the commanding officer was. When the man pointed toward the officer, "the general said, 'stand up when you're talking to a general."" Sestokas jumped in to ask the general if he could help him.

That night, Sestokas went on patrol because one of the units was missing. The next morning as the Battleship Texas blew shells over his head, he said "it sounded like

express trains."

During the battle, he discovered a piece of shrapnel in his helmet and pulled it out. After the unit captured the fort, his head began to bother him. He found the wound had become infected and was placed in the hospital for a month.

"One morning I got up and there was a Purple Heart," Sestokas said.

When he was stationed at Mitchell Field on Long Island, N.Y., he met his future wife, Doris.

"When we arrived, we went through Holland Tunnel with our trucks, horns blowing," Sestokas said. "We were living in tents outside of Mitchell Field. We had to go to the Salvation Army to take showers."

Although he was a Catholic, at the time he attended the Episcopal Church, where he was asked to bring 30 men to a dance hall while the chaplain brought 30 young women. He noticed Doris the first week, but did not dance with anybody. Normally, the women could only attend the dance once a month, but she was there four weeks in a row. When he found that she and the chaplain were in cahoots, he married Doris on Aug. 16, 1942.

After they were married, Sestokas was transferred to Richmond, Va., where he trained with rifles and guns before being deployed overseas during World War II.

The biggest project, in my book, is what they do to adapt clothing to the child's needs. A simple thing like underwear needs to have snaps sewn on the sides to allow them to be put on over casts. They change pajama bottoms and tops for the same reasons. What that requires is cutting, pinning the snaps, and sewing them in place. They do this for the many children who come to the hospital and stay for a time. Volunteers staff this project and they can use materials

After he was wounded in Italy, once he was able to walk, he transferred to Valley Forge Hospital, where he later got a job at the hospital and stayed until he retired several years later.

After working for an insurance company for a short time, he was called back to active duty and joined the Air Force, where he attended a navigator radar observer school and flew in F94 jet fighters for 15 years "in the back seat with the radar and navigation."

After he got out of the fighter squadron, he was assigned to the Air Defense Command in Colorado Springs.

After spending 32 years in the military, serving in Colorado Springs, Newfoundland and later in Thailand, he retired with the rank of lieutenant colonel.

In his leisure time, he received his first degree in the Masonic Lodge, but got orders to go back to the Air Force. Because of that, he was dropped from the rolls; he had to wait until 1962 when he joined a Masonic Lodge in New York. Since then, he has joined numerous Masonic bodies, including Scottish Rite, Shriners, York Rite and several Masonic Lodges. He also ran the dining room in Denver for 10 years and also received several honors including KCCH, 33rd Degree and Mason of the Year.

He and Doris have five children, 10 grandchildren and nine great-grandchildren.

LAW CHANGES REGARDING SALUTING THE FLAG

I felt strongly about the following article after reading it, so thought I would share it with those who do not have access to the Internet or who do not receive the "Army Echoes" Bulletin for Retired Soldiers and their families.

The 2008 National Defense Authorization Act (Public Law 110-181) changed Sect. 9, Title 4, U.S. Code, which covers "Conduct during hoisting, lowering or passing of flag." Following is that section of the U.S. Code, as reworded by the law change: "During the ceremony of hoisting or lowering the flag or when the flag is passing in a parade or in review, all persons present in uniform should render the military salute. Members of the Armed Forces and veterans who are present but not in uniform may render the military salute. All other persons present should face the flag and stand at attention with their right hand over the heart, or if applicable, remove their headdress with their right hand and hold it at the left shoulder, the hand being over the heart. Citizens of other countries present should stand at attention. All such conduct toward the flag in a moving column should be rendered at the moment the flag passes." (Army Echoes, Sep-Dec 2008)

That last sentence came as something new to me because I was taught that you rendered the "Salute" at six paces before the flag passed you and held for six paces after it passed. Now that it is "the law" we need to observe it in our meetings. Be proud of your service to this great nation and show your respect to our flag with the "Salute." Tell your fellow veterans of the change in the law.

The Future Holds No Limits for Colorado Teen

Ambitious amputee pushes boundaries thanks to Shriners Hospitals for Children

Volleyball. Whitewater rafting. Hiking. Hunting. All of these are activities that any Colorado teenager might enjoy. But when talking about a teenager who has lived without her right leg since she was 8 months old, participating in such activities takes on new meaning.

Heidi Duce has fibuler hemimelia. When she was born, her right leg was missing a fibula, ankle bone and three toes and was amputated. From infancy, she's relied on prostheses to maintain her on-thego lifestyle.

"I'm hard on my leg," Heidi laughs.

At just 17 years old, she's already been through 23 or 24 reconstitution and the prosthetics, according to her last count. She knows this wouldn't be possible without Shriners Hospitals for Children -- Salt Lake City, where she receives treatment.

"The people at Shriners Hospitals are just unbelievable," she said. "I couldn't even imagine a world without them they've always been such a huge part of my life."

Heidi will soon begin her senior year of high school and works at her father's service station in Ouray, Colo. "I'm learning to work on cars," she says. She already changes the oil and services her own car. In her spare time, she's out enjoying all

that her home state has to offer... counting hunting with her father and hiking with friends among her many adventurous hobbies.

And while she has plenty of friends in her hometown to hang out with, Heidi cherishes the friends she's made at the "un-limb-ited" camps hosted by Shriners Hospitals for Children. The camps are for children and teens that have disabilities and offer exciting white water rafting and skiing experiences.

"I live in a town of only about 700 people," she explains. "There are no other teen amputees besides me. It's been great to make friends who I can talk to and know they really understand me because they've been through the same thing."

The caring and support Heidi has received from Shriners Hospitals is helping to shape her future. She wants to be a nurse, and eventually, a prosthetist.

"Everyone at Shriners Hospitals for Children is so passionate about what they do it's really cool," Heidi says. "They've given so much to me, and I want to give something back."



New Policy Concerning Delinquent Dues Members

At the June 3, 2008 Board of Directors Meeting, the Board agreed to the following policy relating to delinquent dues:

- 1. Delinquent dues members will no longer be carried on the roles for two years.
 - 2. Nobles whose dues are delinquent for 2007 and 2008 will be suspended for non payment of dues effective December 31, 2008 (no change) if dues are not paid.
 - 3. Nobles who are delinquent for 2008 will be suspended for non payment of dues effective March 31, 2009 if dues are not paid. Further, effective December 31, 2008, nobles names will be removed from Dust and all other correspondence mailings until dues are paid.
- 4. Nobles who are delinquent for 2009 dues and all subsequent years will be dropped for non payment of dues on December 31, 2009 or December 31 of the year dues are not paid.
- 5. Effective with the 2009 year, the restoration fee for nobles that are suspended who wish to be restored to good standing will increase from \$77.00 to \$154.00.

Our intent is not to increase the number of suspended nobles; but, the more efficient management of Al Kaly members and reduce the administrative work associated with carrying nobles for two years on the files.



Shrine Hospital Notes

Surprise! It's budget time at our Hospitals and they are working real hard to make things work, during these difficult times. Our hospital at Salt Lake City, as with all the other Shrine Hospitals, has been given their directions from Tampa and they are working very diligently to make the numbers match. After looking at the directed changes, they now have to look at potential cuts. One item that required a second look was the Outreach Clinics in Boise, Denver and Phoenix and another was the Telemedicine Clinics. After some discussions, it was determined that we at Al Kalv could insure continuance of our four clinics per year by funding the Facilitator and the Communications costs. We normally see about sixty children a year, at our Telemedicine Clinic in Colorado Springs, and if we need to send them to Salt Lake City, for those follow up appointments, the cost would be \$18,000 to \$20,000, as opposed to approximately \$3,500 to support the clinic for a year. A special thanks goes to our Divan, who readily approved Al Kaly support for the continuance of our Telemedicine program.

In September, Salt Lake City Shrine Hospital hosted Divan Days, inviting Divans from all supporting Temples


month of August were the parades in Lamar, Rocky Ford, and the CSSA in Oklahoma City. Members of the Escorts
