Minutes of 11 August 2015 Meeting

- The Salt Lake Hospital is 3rd in obtaining 3rd party payments.
- Hand surgery is now a specialty at Salt Lake.

Noble Guy asked Noble Phil if he would come to the pr meeting once in a while and give updates on hospital status. Noble Phil agreed to provide updates. Nobel Phil and IS Bob to prepare an article for the Dust.

ITEM 3: Noble Doc expressed concern over the clinics and asked where the reps fit in. Noble Phil said he hoped publicity from KRDO would generate interest. It was also discussed that we should visit/revisit some of the local health care organizations, such as PeakVista and review our capabilities with them.
